## Overview

Bill represents mortgage servicers and lenders in prosecuting and defending mortgage foreclosure actions and defending lenders and servicers in "wrongful foreclosure" lawsuits in state and federal courts in both Oregon and Washington. ## **Representative Cases**

## **Consumer Protection Act Defense**

We represented a Washington homebuilder in a lawsuit filed against a real estate investor for breach of promissory note and the judicial foreclosure of the trust deed that secured the note. The defendant

investor attempted to avoid liability for his obligations by asserting Washington Consumer Protection Act counterclaims against our client. At the trial court, we prevailed on a motion for summary judgment granting the client's claims against the investor and defeating the investor's Consumer Protection Act counterclaims. The investor appealed the trial court's rulings. On the appeal, we decisively defeated the investor's complex Consumer Protection Act arguments, and the Court of Appeals affirmed the trial court's rulings.

# **Health Care Facility Construction and Cost Recovery**

We first advised a community hospital on a fast track design/build remedial system in conjunction with construction of a new facility. The property was heavily contaminated by fuel releases from an adjacent gas station. We sued the Responsible Party and obtained full recovery of past costs and a mechanism to recover future costs. We continue to advise the hospital on ongoing remediation and cost recovery issues.
